

SEVENTH AMENDMENT

TO

Montana Lottery Operating System and Related Services

DOA14-2885P-Operations Contract ("Lottery Contract")

This Seventh Amendment to the Lottery Contract ("Seventh Amendment") is made and entered into as of the _____ day of July 2023, by and between the State of Montana, Montana Lottery ("Lottery") and Intralot, Inc. ("INTRALOT"), individually a "Party" and collectively the "Parties."

RECITALS

A. The Lottery and INTRALOT are parties to the Lottery Contract ("Contract") dated February 13, 2015, as amended by Amendments One through and including Six.

B. Pursuant to the Contract, which includes the Request for Proposal (RFP) and INTRALOT's response to the RFP, Intralot provided, among several offered options ("Offered Option(s)"), an Offered Option for non-traditional lottery games, including sports betting.

C. Pursuant to the Sixth Amendment the Lottery chose to exercise the sports betting Offered Option included in the Contract and included certain terms and conditions.

D. The Parties as a result of further discussions now desire to amend certain provisions of the Sixth Amendment, then therefore:

The Parties therefore agree as follows:

1. Section C.1.c shall be deleted in its entirety.
2. Section C.1.d. shall be deleted in its entirety.
3. Section C.1.e.b shall be deleted in its entirety and replaced with the following:

Intralot will enhance software, hardware and replace terminal wraps for all Sport and Traditional NG terminals allowing for the sale of both Sports and/or Traditional games (dual terminals). Software delivery to the Lottery UAT will be June 3, 2024; and Go Live will commence July 14, 2024.

A Statement of Work (SOW), agreed upon by both parties outside this Amendment, will define dual terminal Pilot, Conversion and Go Live.

4. New Section C.1.e.c shall be inserted in its entirety as follows:

c) 4.3 Dream Touch UI

Intralot shall provide a new UI for the DreamTouch kiosk, replace terminal wraps, and add Fast Play Games on DreamTouch kiosks and Photon retail terminals. Software delivery to Lottery UAT will be April 22, 2024; and Go Live will commence June 2, 2024. To ensure dates are met, all ai formatted assets for the reskin must be provided in August, 2023. To ensure dates are met, initial Fast Play offering is limited to 5 games out of the existing games that Intralot has developed in any of their US jurisdictions, no new game concepts. All specs/assets must be finalized by September, 2023.

5. This Seventh Amendment is effective the day and year first written above. This Seventh Amendment, including the Recitals, sets forth the entire understanding between the Parties regarding the matters set forth herein and supersedes all prior representations, understandings, or agreements, whether written or oral, express, or implied regarding those matters specifically set forth herein, but shall not be deemed to be waiver of either Party's right to enforce any and all provisions of Contract, except as set forth in this Seventh Amendment. If a conflict exists between the terms and conditions of this Seventh Amendment and the 2015 Agreement, the terms and conditions of the Seventh Amendment govern.
6. This Seventh Amendment binds and benefits the State and INTRALOT and their respective successors and assigns.
7. This Seventh Amendment may be executed in multiple counterparts, each of which shall be deemed an original and all of which together shall have the same legal effect as if the parties had signed a single document.
