 By being granted a license from the Montana Lottery you, your employees and agents agree to comply with ALL Terms and Conditions in the application, the Lottery's Administrative Rules (2.63.101—2.63.1305) and State Statutes (23-7-101—23.7.412) that regulate Lottery operations.

- Any Lottery sales agent license may not be transferred, sold, or assigned.
- Any licenser of traditional or sports wagering sales agents in Montana exists solely by virtue of legislative permission
- A sales agent license is a privilege and is subject to withdrawal or condition resulting from legislative changes.
- The Montana Lottery may revoke a license if the licensee (a) fails to follow the provisions of the Montana State Lottery Act and the associated administrative rules; (b) no longer meets the criteria for a license; or (c) is no longer eligible for a license due to a change in law.
- If a provision in the licensing documents provided to a licensee conflict with an applicable statutory or regulatory provision, the statutory or regulatory provision preempts the conflicting provision in the licensing documents.
- The licensee will immediately notify the Montana Lottery of any change in business ownership, financial institution, bank account or business location.
- To educate employees and agents regarding lottery products and promotions, applicable Montana law and the Lottery's rules and directives
- To not claim to be a licensed Lottery premise unless a license is granted
- To prominently display the license within its premise and to prevent theft or defacing of the license
- That all Lottery Scratch tickets activated for sale (except for those returned or adjusted in accordance with Lottery procedure) are considered to have been purchased by the licensee and are the licensee's property
- Your primary business cannot be solely the sale of Lottery products
- To pay for all Lottery products by Electronic Funds Transfer (EFT) and with other directives of the Montana Lottery
- Maintain in good condition all authorized equipment, supplies (i.e., terminal paper), displays, notices, and other materials used to make Lottery product sales
- A sales agent will be required to maintain adequate weekly sales as determined by the Montana Lottery to continue to retain Lottery terminals, and/or license. Additional information or adjustments will be provided to the sales agent before such action is taken
- To immediately contact the Lottery or customer service when the terminal is not operational to minimize sales losses
- To redeem all winning Lottery tickets up to \$599.99 in full as authorized by the Montana Lottery
- Lottery tickets will be sold only on the premises of the business designated on the license
- Persons selling and/or buying Lottery products must be 18 years of age or older
- Lottery products will not be sold at a price greater than the price stated on the ticket
- To maintain professional conduct in all interactions with and pertaining to the Montana Lottery
- To have all Lottery terminals, dispensers, and products available to all Lottery personnel or contractors during all regular business hours, unless otherwise mutually agreed upon between the Lottery and the licensee
- A sales agent must provide two weeks' notice prior to a change of ownership. If two weeks' notice is not provided, the applicable sales agent may be charged for all existing Lottery products on location




